4. Electronic Bids must be submitted to the Police Headquarters Operation & Crime Investigation Department Naxal, Kathmandu through PPMO's website: www.bolpatra.gov.np/egp on or before 12:00 noon, 24 December, 2019 (08/09/ 2076) Documents received after this deadline shall not be accepted.

The Bids will be opened in the presence of Bidders' representatives who choose to attend 24 December, 2019 (08/09/2076) at 14:00 hours at Police Headquarters Operation & Crime Investigation Department Naxal, Kathmandu Nepal. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, which shall be valid for minimum 30 days beyond the bid validity period.
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
