- Electronic bids must be submitted to the office Nepal Police Head Quarters, Administration Department Financial Administration and Procurement Directorate, Naxal, Kathmandu through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 19th Poush, 2081 (03rd January, 2025) at 12:00 hours. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend on 19th Poush, 2081 (03rd January, 2025) at 14:00 hours at the office of Nepal Police Head Quarters, Administration Department, Financial Administration and Procurement Directorate, Naxal, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period of the bid.
