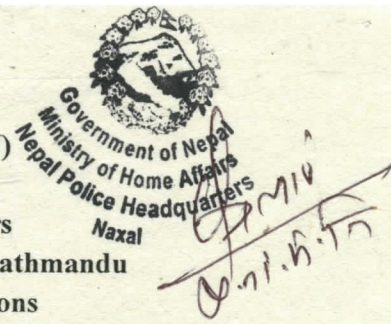

4. Electronic Bids must be submitted to the Procurement Directorate, Nepal Police Head Quarters, Naxal, Kathmandu through PPMO's website: www.bolpatra.gov.np/egp on or before 07th June, 2022 (24th Jestha, 2079) at 12:00 noon. Documents received after this deadline shall not be accepted.

The Bids will be opened in the presence of Bidders' representatives who choose to attend 07th June, 2022 (24th Jestha, 2079) at 14:00 hours at Procurement Directorate, Nepal Police Head Quarters, Naxal, Kathmandu Nepal. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, which shall be valid for minimum 30 days beyond the bid validity period.

4. Sealed bids must be submitted to the office of Procurement Directorate Police Headquarters, Naxal, Kathmandu by hand before 12:00 hrs on 23rd May, 2022 (09th Jestha, 2079). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend 23rd May, 2022 (09th Jestha, 2079) @ 14:00 hrs at the office of Nepal Police Headquarters, Procurement Directorate, Naxal, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.1100203 at Rastriya Banijya Bank, Thamel and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
