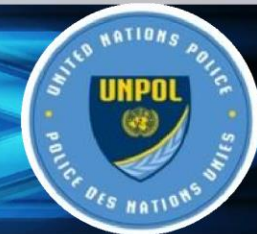




UNMISS UNPOL IN ACTION

UNPOL -MHQ



On 30 June 2022, Police Commissioner Madam Christine Fossen, Chief Of Staff Mr. Murat Isik, Juba FOPC Mr. John Baptist Claude Murangira, Brig.Gen Madhab Thapa, Force Headquarters Juba, and FPU Commander SSP Prakash Thapa officiated at the Medal Parade for 43 IPOs from Nepal, (39F/4M) at Payam UN House. Madam Christine appreciated the officers' commitment, sacrifice and hard-work in serving to protect lives of civilians in South Sudan. The PC also reminded them of preservation of UN core values, adding that the Zero Tolerance Policy against SEA must be adhered to.











On June 30, 2022, at 11.00 hrs, the UNPOL officers from Rotation, PLDU, and Immigration units received the first two (1M/1F)Angola police officers, MS Sarita Domingos and Mr. Jose Valente Pimpao, deployed to UN peacekeeping operations. Sarita who has been the station commander in Angola and very excited to serve UNPOL here in UNMISS, South Sudan.





UNPOL –JUBA



The team proceeded to IDP Camp 3 and paid a visit to the CMC office where there was an interaction with the Chairperson Borja Madiet, two other males and one female. The chairperson said that the security situation was calm though there had been a gang fight in the camp on the 27th of June 2022 around 17:00 hours. The gang members disappeared after the fight and even the injured members could not be located.



The Team visited the IMC Clinic, Maternity wing and interacted with Stella Simon. She informed the team that the situation was calm and normal.

The team proceeded to the CWG office where there was a meeting for camp leaders going on. The team managed to interact with the Assessment Chief of CWG Lual Lok Buodit and two other male members. He met the team outside and informed it that the situation was calm and normal, there were no new cases, he also talked about the earlier mentioned gang fight.





On 30 June 2022, UNPOL team from FOJ conducted PCRC outreach program activities in Jundoro community to a group of 200 people.



UNPOL - WAU



On 29 June 2022, UNPOL team went on patrol and sensitization to Hai El Jau area and pay a courtesy visit to the PCRC Chief Paul S. The team interacted with him he stated that the security situation of the area is normal. The team sensitized him on the role of community leaders in crime prevention and a reminder on COVID-19 preventive measures.





On 29 June 2022, the CP & GCVPP team conducted a mobile patrol in Wau IDP Camp (former POC AA). During the patrol, the team interacted with Rosa A. The team sensitized her on the role of community members in crime prevention and to observe COVID-19 preventive measures. All areas patrolled were peaceful at the time of patrol. She stated that the security situation in the IDP camp is calm and peaceful and CWG are patrolling the area.

On 29 June 2022 UNPOL Team of 1M GCVPP Officer & 1F PIO Joined PTR, UNMISS Engineering, SAVE THE CHILD and UCDC for a Joint Monitoring of the two ongoing projects Zagolona and Hai Baggari Police Station.

UNPOL -BENTIU



On 28 June 2022, UNPOL Officers from Community Policing visited Rubkona TOWN Bentiu IDP Camp for a sensitization activity. The team interacted with one Angelina Douk together with others present. The team talked about Peace, Love, Unity among them self and as a parent speak to their children and encourage the children to learn hard in their schools so that tomorrow, they will be good Ambassadors of South Sudan.



On 28 June 2022, UNPOL officers PA Alfred Chiwambo and PA Kelvin Mwamba from capacity building and development pillar visited Bentiu police headquarters for an engagement meeting and interacted with the police commissioner Major General Gordan Machar Yiek who was with four (4M) SSNPS police officers. The team reminded the Police Commissioner about the trainer of trainer's workshop to be conducted by UNPOL officer to identify officers under his command who will be trained as trainers jointly they will be accompanying UNPOL training team whenever they are conducting trainings for SSNPS.



On 27 June 2022, UNPOL Team leader Harriet Nleya and OIC Team Leader Nuru went to the Buffer zone area in the IDP Camp on observation. The team observed that people are still cultivating their garden along the buffer zone near to UNMISS base fence between Gate 4 and Gate 5. The team also noted that people regardless of many efforts to chase them away and the meetings held with the SSNPS Commanders to assist.



On 28 June 2022, GCVPP Officers along with Humanitarian's workers, from Non-Violence and Greater Upper Nile Organizations (GUNO) participated in day one, of a three day Coordinated GBV Safety Audit Assessment, at Briyang Community (SITE_C). Participants requested for more sensitizations on SGBV, schools, recreational centers, and police stations as measures to curb these issues faced with the community. The women requested to be provided with some family planning method and also, they said they need dignity kits.





UNPOL -RUMBEK



On 29 June 2022, the SSNPS Workshop on Investigation and Prosecution went on very well during the second day of the course. All the 75 participants were present to attend the lectures. All went on very with participants acquiring important knowledge that is relevant to their day-to-day duties.



On 30 June 2022 Rumbek Field Office UNPOL Crime Advisory Team comprising 04 PAs (02M&02F) went to Cui Adukan Police Post and sensitized 07M Police officers on the Topic “TAA: Criminal Justice system in South Sudan”. Members were encouraged to perform their duties in accordance with their criminal laws and the constitution of their land. Emphasis on Observation of Human Rights when performing police duties was made to the officers.





UNPOL -MALAKAL



On June 29 2022, Malakal UNPOL, UNPOS, MEDAIR, UNICEF, IOM and other relevant partners attended Wunthou Immigration Post and Ribbon cutting ceremony at Geiger Youth Center with the presence of the guest of honor, His Excellency the Ambassador of Germany. Wunthou is at the border between South Sudan and Sudan in the administrative district of Rank. The security situation was relatively calm and normal.



On June 28, 2022, from 0930 hours to 1200 hours UNPOL Liaison Officer Tt Col. Ahmed Mokbel from Occupational Safety and Health Compliance Officer (OSH) with FPU Coordinator Cell Officer-PA Guy Rodrigue Tigati conducted inspection in Malakal RWAFFPU-1 covering various aspects including transportation safety and workshop, food, fire, ablution, and general hygiene safety. The inspection ended without any incident. Overall, the Inspectors expressed their satisfaction.





UNPOL -BOR



On 29 June 2022, UNPOL team of three IPOs (01M\02F) conducted a workshop at women friendly space on road safety and management. The team recap on yesterday topics, positive answers were given by participants, answers on importance of wearing helmets and speeding hazards, traffic documents like driving license, logbook of vehicle, insurance certificate, inspection certificate, general driving license for heavy trucks , and driving license for personal use , the rights of pedestrians and other road users.



On 29 June 2022, two (01F&01M) IPOs along with one CLA with the protection of Inbatt conducted ISDP to Pariak. The team visited Pariak police station and interacted with CPL Awar Tot Daniel in charge of general duties and other four officers. He said security situation was now calm no attacks and cattle raiding they have been working hand in hand with Local chiefs to protect their community. He informed that they still face a problem of detaining room because if they arrest a person before transferring to Bor Town he/she has to be kept for 24hrs. The team sensitized On the importance of protecting SGBV cases victims. The team also tried to reach a Local chief he was not present due rain.



On 30 June 2022, four IPOs conducted collocation at River side police post and interacted with Director Maj. William Kuany Kuot apart from the incident of dead body identified passing to the direction of Malakal on 17th June 2022 and diapered no any other case has been reported, security situation is normal and calm. Fourteen officers were present in different assignments, patrols and operations along the river.





UNPOL - AWEIL



On 30 June 2022 UNPOL Team comprising of two (02M/00F) GCVPP/CP officers with (01/M) LA left the base for a mobile patrol to observe and monitor security situation, human rights violations and to give Technical Assistance and Advise to SSNPS Officers. The UNPOL Team visited Maper, Aweil, Traffic, CID, and SPU Police formations and met a total of 25 (21M/04F) SSNPS Officers. The SSNPS officers were sensitized on the topic of Abduction as a Grave Violation.



On 28 June 2022, the UNPOL conducted three (03) days of training for Police Investigators and public Prosecutors on the topic of Crime scene investigation. The training coordinated by the UNPOL team was held at the Grand Aweil hotel from 23rd to 25th June 2022 and 22 participants (18M/04F) attended to the 3 days training.

On 28 June 2022, at about 0900hrs UNPOL team with PTR section/Engineer of UNMISS embarked on ILDP to Abiey Chok Tonj South for inspection and monitor the construction of Abiey Chok police station.





UNPOL -TORIT



On 28 June 2022, UNPOL TAA team visited Torit municipality police station and interacted with Major Justine Kileopas. He reported that the security situation within the past 24hrs has been quiet and calm. There were no serious cases reported.

On 28 June 2022, the UNPOL team and one female translator conducted the second day of workshop at the ARK hotel in Torit, for the senior officers (18M/06F) from the traffic department, second day topics of the workshop are traffic duties and traffic investigations.
