3. Pre-Bid Meeting shall be held at Nepal Police Headquarters, Administration Department, Financial Administration and Procurement Directorate, Naxal, Kathmandu on 11th April, 2025 (29th Chaitra, 2081) at 14:00 hours.
4. Sealed bids must be submitted to the office of Nepal Police Headquarters, Administration Department, Financial Administration and Procurement Directorate, Naxal, Kathmandu by hand before 12:00 hrs on 20th April, 2025 (07th Baisakh, 2082). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend 20th April, 2025 (07th Baisakh, 2082) @ 14:00 hrs at the office of Nepal Police Headquarters, Administration Department, Financial Administration and Procurement Directorate, Naxal, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 110010010203000 at Rastriya Banijya Bank, Thamel and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
