2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing "The Technical Bid" and the other "The Price Bid" as per the provision of ITB 23 of the Bidding Document.

4. Bidder must submit their bid electronically as per e-GP System Operation Guidelines, 2074. Bidder can download the bidding documents for e-submission form PPMO's website www.bolpatra.gov.np/egp. Bidders submitting their bid electronically, should deposit the cost of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-Bid Meeting shall be held at Central Investigation Bureau, Maharajgunj, Kathmandu on 2nd January, 2023 (18th Poush, 2079) at 11:00 hours.
6. Electronic Bids must be submitted to the **Central Investigation Bureau, Maharajgunj, Kathmandu through PPMO's website: www.bolpatra.gov.np/egp** on or before 16:00 hours, 12th January, 2023 (28th Poush, 2079) Documents received after this deadline shall not be accepted.
7. The Bids will be opened in the presence of Bidders' representatives who choose to 13th January, 2023 (29th Poush, 2079) at 11:00 hours at **Central Investigation Bureau, Maharajgunj, Kathmandu, Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
