2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing "The Technical Bid" and the other "The Price Bid", as per the provision of ITB 23 of the Bidding Document.

4. Bidder must submit their bid electronically as per e-GP System Operation Guidelines, 2074. Bidder may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at Nepal Police Head Quarters, Financial Administration and Procurement Directorate, Naxal, Kathmandu on **28<sup>th</sup> May, 2023 (14<sup>th</sup> Jestha, 2080)** at 14:00 hours.
6. Electronic bids must be submitted to the office **Nepal Police Head Quarters, Financial Administration and Procurement Directorate, Naxal, Kathmandu** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **07<sup>th</sup> June, 2023 (24<sup>th</sup> Jestha, 2080)** at 12:00 hours. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend on **07<sup>th</sup> June, 2023 (24<sup>th</sup> Jestha, 2080)** at 14:00 hours at the office of **Nepal Police Head Quarters, Financial Administration and Procurement Directorate, Naxal, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period of the bid.
8. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
