5. Bidder must submit their bid electronically as per e-GP System Operation Directives, 2080. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following account as specified below.

6. Pre-bid meeting shall be held at Nepal Police Headquarters, Welfare Division, Naxal, Kathmandu on 23<sup>th</sup> February, 2024 (11<sup>th</sup> Falgun, 2080) at 14:00 hours.
7. Electronic bids must be submitted to the office **Nepal Police Headquarters, Welfare Division, Naxal, Kathmandu** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 5<sup>th</sup> March, 2024 (22<sup>th</sup> Falgun, 2080) at 12:00 hours. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 5<sup>th</sup> March, 2024 (22<sup>th</sup> Falgun, 2080) at 14:00 hours at the office of **Nepal Police Headquarters, Welfare Division, Naxal, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid i.e.
9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
