5. Pre-bid meeting shall be held at Kathmandu Valley Police Office, Ranipokhari, Kathmandu on 14th February, 2023 (2nd Falgun, 2079) at 14:00 hours.

Electronic bids must be submitted to the office Kathmandu Valley Police Office, Ranipokhari, 6. Kathmandu through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 1st March, 2023 (17th Falgun, 2079) at 12:00 hours. Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend on 1st March, 2023 (17th Falgun, 2079) at 14:00 hours at the office of Kathmandu Valley Police Office, Ranipokhari, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period of the bid.
