4. Bids must be submitted to the office of Nepal Police Head Quarters Welfare Division, Naxal, Kathmandu by hand before 12:00 hrs on 04 Jetha, 2079 (18th May, 2022). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidder's representatives who choose to attend 04 Jetha, 2079 (18th May, 2022) @ 14:00 hrs at the office of Nepal Police Head Quarters Welfare Division Naxal, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, which shall be valid for minimum 30 days beyond the bid validity period.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
