3. Bidder must submit their bid electronically as per e-GP System Operation Guidelines, 2074. Bidder can download the bidding documents for e-submission form PPMO's website www.bolpatra.gov.np/egp. Bidders submitting their bid electronically, should deposit the cost of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Pre-Bid Meeting shall be held at **Police Headquarters Crime Investigation Department Naxal, Kathmandu** on **20 January, 2022 (06/10/2078)** at 14:00 hours.
5. Electronic Bids must be submitted to the **Police Headquarters Crime Investigation Department Naxal, Kathmandu** through PPMO's website: www.bolpatra.gov.np/egp on or before **30 January 2022 (16/10/2078)** at 12:00 noon. Documents received after this deadline shall not be accepted.
6. The Bids will be opened in the presence of Bidders' representatives who choose to attend on **30 January 2022 (16/10/2078)** at 14:00 hours at **Police Headquarters Crime Investigation Department Naxal, Kathmandu, Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
8. **Police Headquarters Crime Investigation Department Naxal, Kathmandu** reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
9. The bidder who has been punished for a profession or business related offenses, black listed company, Firm, person and a company fully or partially owned by black listed company are not eligible to bid.
