3. Pre-Bid Meeting shall be held at Nepal Police Headquarters, Financial Administration and Procurement Directorate, Naxal, Kathmandu on 19th Jan, 2023 (05th Magh, 2079) at 14:00 hours.
4. Sealed bids must be submitted to the office of Nepal Police Headquarters, Financial Administration and Procurement Directorate, Naxal, Kathmandu by hand before 12:00 hrs on 29th January, 2023 (15th Magh, 2079). Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend 29th January, 2023 (15th Magh, 2079) @ 14:00 hrs at the office of Nepal Police Headquarters, Financial Administration and Procurement Directorate, Naxal, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.1100203 at Rastriya Banijya Bank, Thamel and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
