Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend 11<sup>th</sup> May, 2026 (28<sup>th</sup> Baisakh, 2083) @ 14:00 hrs at the office of Nepal Police Headquarters, Administration Department, Financial Administration and Procurement Directorate, Naxal, Kathmandu.
