- 6. electronic bids must be submitted to the office *Kathmandu Valley Traffic Police Office Ramshapath Kathmandu* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 3rd May, 2024 (21st Baishkha, 2081). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours, 3rd May, 2024 (21st Baishkha, 2081) at the office of Kathmandu Valley Traffic Police Office Ramshapath Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
