2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

4. Bidder must submit their bid electronically as per e-GP System Operation Guidelines, 2074. Bidder can download the bidding documents for e-submission form PPMO's website www.bolpatra.gov.np/egp. Bidders submitting their bid electronically, should deposit the cost of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-bid meeting shall be held at Nepal Police Headquarters, Crime Investigation Department, Naxal, Kathmandu. on **16 April, 2024(04/01/2081) at 14:00 Hours**.
6. Electronic Bids must be submitted to the Nepal Police Headquarters Crime Investigation Department, Naxal, Kathmandu through PPMO's website: www.bolpatra.gov.np/egp on or before **02 May, 2024 (20/01/2081) at 12:00 noon**. Documents received after this deadline shall not be accepted.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend on **02 May, 2024 (20/01/2081) at 14:00 hours** at Nepal Police Headquarters, Crime Investigation Department, Naxal Kathmandu, Nepal. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security which shall be valid for minimum 30 days beyond the bid validity period.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
